The competition will be held during the Italian BikeTrial Championship competition. The foreign competitors don't take part to Italian BikeTrial Championship ranking. All competitors in Elite Category participate in Mediterranean International BikeTrial Gran Prix (MIB GP 2010).

### Prize

Prize money for the top 3 riders of Elite with € 500, 300 and 200 respectively.

Medals and trophy for the top 3 riders of each category. Special prize for first Italian Rider.

### Entry List

The Entry List closing (dead line) the 15<sup>th</sup> July 2010 at 20:00 o'clock. All foreign rider are admitted in competition with “waiver and release form”. “Waiver and release form” will be sign before the start.

The fee is € 15 per rider with pre-registration via Web. € 25 without pre-registration.

#### NAME AND LIKENESS RELEASE

### SEVERALTY OF PROVISIONS


